### On-site flu vaccinations

Health Tick provides onsite flu vaccination at the workplace or in the Health Tick mobile van. Our vaccination programme is delivered by registered nurses authorised by the Medical Officer of Health to provide vaccinations.

The rollout of this service is an easy 4-step process



**1 PLAN** – Once your booking request is received, our dedicated programme coordinators work with you on your preferences for dates, times, service location (at workplace or via mobile van) and booking system options (appointment times or drop-in).



**2 PROMOTE** – Promotional material including posters, FAQs and template emails are provided to you via email to help increase programme uptake.



**3 DELIVER** – On the day, our nurse(s) will arrive at your workplace fully equipped to vaccinate your staff.



**4 REPORT** – Following completion of all vaccinations, an organisational report is provided. The report outlines the details of the programme, including uptake across your site(s).



### **Set Up Requirements for the Day of Vaccination**

- 1. Private room for the vaccinator (private health information may need to be discussed)
- Additional area adjacent to room or nearby where individuals can complete their post-vaccination wait

### **Flu Vaccination Terms and Conditions**

- 1. All pricing excludes GST
- 2. Invoicing is based on actual numbers vaccinated and minimum booking charges apply (refer to individual guote)
- 3. Cancellations less than 5 working days' notice will incur a 50% fee. Cancellations within 48 hours will be charged 100% of the minimum booking fee
- 4. IRD km rate of \$0.95 applies to all travel by the nurse
- 5. Travel rate of \$100/ hour may apply where travel is required beyond a 15km radius of the nearest Health Tick office to where the service is provided
- 6. Overtime nurse rate of \$180/hour may apply where the booking time is exceeded due to client delays
- 7. Visits between the hours of 5pm and 7am will incur a 30% surcharge. Visits on a public holiday with incur a 50% surcharge
- 8. Flu vaccine voucher payment is due upfront at the time of placing the order
- 9. Flu vaccine vouchers are valid until 31st July 2024
